

SPONSORSHIP AND EXHIBITION PAYMENT CONDITIONS

These conditions have been effected for the mutual benefit of the chiropractic profession, associated sponsor and exhibition companies, supporting venue and staging organisations, World Federation of Chiropractic and the Australian Chiropractors Association Limited. We appreciate your compliance with these terms.

- 1. All prices in this document are in Australian Dollars (AUD) and inclusive of GST.
- 2. The Sponsorship and Exhibition Booths will be allocated strictly in accordance with the date of receipt of application form and payment.
- 3. A 50% deposit is required and must be sent with the application form. The balance for Exhibition Booths is to be paid no later than the 30 June 2023. A letter of confirmation will be provided, together with a Tax Invoice for the full amount payable.
- 4. Sponsorship is to be paid in full upon application. A sponsorship agreement will be provided, together with a Tax Invoice for the full amount payable.
- 5. Exhibitors must abide by the rules of the Gold Coast Convention and Exhibition Centre. Bump-in and Bump-out times must be strictly adhered to.

- 6. No Sponsor or Exhibitor will be allowed to participate until full payment has been received by the due dates.
- 7. Should you wish to make a direct deposit please see page 7 for details.
- 8. Should cancellation of the congress be instigated by WFC and ACA Limited, all monies paid by a Sponsor or Exhibitor will be refunded.
- 9. Should a Sponsor or Exhibitor cancel prior to the 30 June 2023, a service fee of 50% will apply. No refunds on Sponsorships and Exhibition will be made for cancellation after this date.
- 10. WFC and ACA Limited reserves the right of refusal of any application and no reason will be offered in the event that this occurs.

SPONSORSHIP AND EXHIBITION TERMS AND CONDITIONS

- 1. No sub-letting/sharing of booths or display stand space is permitted.
- 2. Equipment emanating higher than reasonable noise levels must be identified and approved prior to acceptance by the WFC and ACA Limited.
- 3. Sponsors and Exhibitors will respect the rights of fellow exhibitors and maintain appropriate care of the property of the Gold Coast Convention Centre and Pyramid Displays.
- 4. No promotional material may be distributed (eg on seats in educational presentation areas) or displayed outside of the booth without permission by WFC and ACA Limited.
- 5. No individual exhibitor may instigate external or cross promotion relating to chiropractic or chiropractors during the period of the congress without consultation and permission by WFC and ACA Limited.

- 6. Sponsors and Exhibitors are responsible for providing all their requirements ie banners, promotional material and other material within the timelines outlined in this prospectus.
- 7. Sponsors and Exhibitors are responsible for the security of all their equipment and materials while at the forum.
- 8. The event organiser, WFC and ACA Limited and the venue, Gold Coast Convention Centre, will not be held liable for damage or loss of goods or equipment while at the conference.
- 9. Whilst every care is taken in the program content/structure, the event organiser, WFC and ACA Limited, reserves the right to alter/ substitute components to the event as deemed appropriate.

SPONSORSHIP AND EXHIBITION INSURANCE REQUIREMENTS

- 1. Insurance is the responsibility of the individual Sponsor and/or Exhibitor.
- 2. All Sponsors and Exhibitors are required to ensure that they are covered for Public and Products Liability Insurance of no less than AUD \$10 million.
- 3. A copy of your Public Liability Certificate of Currency from your insurer must carried with you at the event and must state the following:
 - Cover Amount: At least AUD \$10 million
 - Cover Period: 1.00pm Wednesday 11 October 2023 to 5.00pm Saturday 14 October 2023.
 - Includes cover for "Exhibitors" for anywhere in Australia (or similar wording).

- Dates cover the congress bump in/out periods.
- Notes the interests of World Federation of Chiropractic and Australian Chiropractors Association Limited as principal in organising the congress.
- 4. Please note that whilst security is provided, neither the World Federation of Chiropractic, Australian Chiropractors Association Limited, nor the Gold Coast Convention and Exhibition Centre will be held responsible for the safety of any exhibits or personal belongings of any kind brought into the exhibition by exhibitors.
- 5. Exhibitors must carry all necessary insurances including insurances to cover all exhibits and personal possessions against damage, loss and public liability insurance against injury to the person and property of others.

Additional notes

In the event of industrial disruptions or natural disasters, the World Federation of Chiropractic and Australian Chiropractors Association Limited cannot accept responsibility for any financial losses incurred by exhibitors, nor for injury or damage to persons or property occurring during the congress. Insurance is the responsibility of the exhibitor.
